*2. In addition to the above, as of December 31, 2010, the Company held 24,102 shares of treasury stock, representing 0.34% of the total number of shares issued.

*3. In regard to LGI/Sumisho Super Media, LP (Super Media), which was listed as a major shareholder as of December 31, 2009, following the cancellation of its limited partnership agreement with the Company, on February 18, 2010, it allocated 1,648,402 shares of J:COM stock to Sumitomo Corporation, after which Sumitomo Corporation became one of J:COM's major shareholders. Further, on February 26, 2010, Super Media changed its name to KDDI Global Media, LP.

*4. All of the shares held by Trust & Custody Services Bank, Ltd. and Mizuho Trust & Banking Co., Ltd. are shares related to fiduciary services.

*5. The Amendment Report Regarding the Large Shareholding Report submitted by KDDI Global Media, LP on April 28, 2010, included the following: (i) On February 18, 2010, KDDI International Holdings, LLC (KDDI International) concluded a securities entrustment agreement with Mizuho Trust & Banking Co., Ltd. and entrusted 152,904 shares to be managed, (ii) in relation to these entrusted shares, KDDI International does not have the authority to exercise or give instructions regarding voting rights or any other rights and does not have the authority necessary to make any investment or give instructions regarding investment, (iii) only in certain cases, all or a part of the entrustment may be terminated and the entrusted shares may be returned, and (iv) these 152,904 entrusted shares are included in the shares owned by KDDI International (253,675 shares according to the above Large Shareholding Report).

*6. On March 17, 2011, KDDI Corporation (KDDI) submitted a Large Shareholding Report announcing that the dissolution of KDDI Global Media, LP and KDDI International Holdings, LLC had been approved on March 11, 2011. Following the dissolution of these companies, KDDI acquired all 2,133,797 shares of J:COM that both KDDI companies had either directly or indirectly owned. (The Large Shareholding Report also reported the fact that the number of shares held by KDDI included the 152,904 shares entrusted to Mizuho Trust & Banking Co., Ltd. under the securities entrustment agreement.) Further, as part of the liquidation of KDDI International, the privileges such as the trust beneficiary rights associated with the securities entrustment agreement detailed in No. 5 above were transferred to KDDI following an agreement concluded between KDDI International, KDDI, and Mizuho Trust & Banking Co., Ltd. on March 11, 2011.
